1. CONTEST PERIOD

The Contest is run by the Oakville Wellness Center and will take place from June 1st, 2017 at 12:00:01 a.m. CST to June 29th, 2017 at 11:59:59 p.m. CST (the "Contest Period"). The Oakville Wellness Center reserves the right to cancel, terminate, modify, amend, extend or suspend the Contest, and select a winner from previously received applicable eligible Entries.

2. ELIGIBILITY

The Contest is open to all legal residents of Canada and the United States of America who:

- 1) are currently enrolled or accepted into a full-time or part-time in Bachelors Degree at an accredited university or college in Canada or the United States of America;
- 2) are (18) eighteen years of age or older as of the date of entering the Contest;
- 3) have agreed to comply with applicable laws (including, but not limited to, libel and obscenity), assume responsibility for their activities, and not to harass, disrupt, abuse, or invade the privacy rights of others; and
- 4) have read and accepted, and agreed to comply with these Rules.

Once these essays are collected, The Oakville Wellness Center will judge these entries and, based on his sole and absolute discretion, will select one (1) winner on or about July 31st, 2017.

Contacting Selected Entrants: The Oakville Wellness Center or his designated representative will make a minimum of two (2) attempts to contact the selected entrant by email or telephone using the information provided at the time of entry within 5 business days of the Draw Date. If the selected entrant cannot be contacted (i.e. cannot successfully be reached by email or telephone by the The Oakville Wellness Center or his representative) within 10 business days of the Draw Date, then he/she may be disqualified (and will forfeit all rights to the Prize) and the The Oakville Wellness Center reserves the right, in his sole and absolute discretion, to select an alternate selected
